DIRECTIONS TO THE TRIAL SITE

From I-40 East or West, the Asheville area, or points north: Take I-26 East to Exit 40; go right (west) for approximately .6 miles. Turn left onto Fanning bridge Road and right into the arena parking lot. **From the South:** Take I-26 West to Exit 40. Go left (west) for approximately .7 miles and follow directions above.

SHOW SITE

These trials will be held in an indoor arena on packed dirt and an adjacent covered outdoor arena on packed dirt. There should be plenty of room for crating. A concession stand will be open during trial hours. There are many restaurants within easy driving distance of the arena and motels.

NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Puppies under 6 months of age are strictly prohibited from the grounds.
- The trial-giving club, the Trial Secretary, their agents, employees, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Returned checks do not constitute a valid entry fee. There will be a \$25 service charge for returned checks. Refunds of less than \$5 will not be made.
- All dogs must be on a leash at all times except when in the ring or when in the designated agility warm-up area. Exhibitors are responsible for being at the ring gate when it is their turn to run. Obstacles shall meet the specifications for obstacles in the current edition of “Regulations for Agility Trials”.
- **Bitches in season and ill or injured dogs are not eligible to compete.** These dogs may be withdrawn after closing and entry fees (less \$5.50/run for ill or injured dogs and \$2.50/run for bitches in season – our direct costs) returned upon request of the competitor prior to the start of the trial. **All requests must be accompanied by a veterinarian’s statement.**
- Exhibitors should follow their veterinarians’ recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries will not be accepted. All entries must be made on official AKC Entry Forms or copies and **must include the Agreement and Rules.** No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

DOGS ELIGIBLE TO ENTER

These trials are open to all dogs 15 months of age or older, that are registered with the American Kennel Club or that have obtained AKC ILP, PAL, or AKC Canine Partners Listing numbers, or are approved FSS breeds. Dogs with a PAL/ILP or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance are not eligible to participate.

MOVE-UPS

Move-up requests for Friday must be made in writing and must be received by the Trial Secretary no later than Monday, May 24, 2010 at 6 p.m. They may be emailed to pegfranklin@morrisbb.net. Provide dog's call name, owner's name, original class entered and new class requested. Move-ups for Saturday and Sunday must include the above information and must be delivered to the Trial Secretary at the trial site no later than 20 minutes after the final dog has run. Dogs moved up will generally be placed at the end of the running order.

CONFIRMATIONS

If you provide an email address, final confirmation of your entry and a schedule of judging will be sent to the email address provided—you will NOT receive a confirmation via US mail. If you do not provide an email address, your confirmation of entry and judging schedule will be mailed to the address provided on your entry form. If you have not received a copy of your confirmation five days before the show, contact the Trial Secretary.

MEASURING

Effective 1-1-2010, exhibitors are no longer required to provide proof to the Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Dogs without a valid jump height card/form may still compete, but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class. This measurement will be valid for that weekend of trials only. Dogs entered in the 24" or 26" height division are excepted from this requirement. However if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present, ALL dogs without a valid jump height card/form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure before the dog's first run of the trial. **It is the exhibitor's responsibility to have their dog measured prior to running, and failure to do so will result in the cancellation of any qualifying scores.**

Owners are responsible for entering the proper height divisions. Handlers of dogs in Regular Classes may opt to run in a higher height division, but not in a division lower than their proper height division. Dogs entered in the Preferred Classes **MUST** jump in their measured division and are not allowed to jump higher or lower.

INTERNATIONAL SWEEPSTAKES CLASSES

The International Sweepstakes Class (ISC) is a non-regular class providing an opportunity to demonstrate advanced training and handling skills on international style Standard and JWW courses. The rules for this class are generally based on international rules. International Agility course designs are very diverse. The total challenge level may be easier, more difficult or simply different from what is currently allowed in the Excellent Class. Course designs will vary widely, thus testing different skills on different days. **ISC is open only to dogs that are eligible to compete in both the Excellent Standard and Excellent JWW class, Regular or Preferred.** Jump heights:

Mini	Jump Height 14"	For dogs 13.75" or less at the withers
Midi	Jump Height 18"	For dogs 16.88" or less at the withers
Maxi	Jump Height 26"	For dogs over 16.88" at the withers

PRIZES AND AWARDS

Rosettes and dog toys valued at \$1-\$3 will be awarded to the 1st through 4th place teams in each jump height in each class. Dogs must qualify to receive placement ribbons. Qualifying ribbons will be awarded to all dogs receiving qualifying scores. MACH and PAX ribbons and bars will be awarded to dogs that earn those titles at this trial. **ISC class winners in each jump height will receive cash prizes in the amount of 30% (1st place), 20% (2nd place) and 10% (3rd place) of entry fees in that height.**

HOW TO ENTER THE TRIAL

****NEW**** - You do not need to send a copy of your height card. Just remember to check the appropriate box on the entry form regarding your dog's measurement status. Checks should be made out to Blue Ridge Agility Club, or BRAC. **PLEASE DO NOT STAPLE** your check to the entry form. Entry fees of \$15 for each run include AKC recording fees of \$3 for each entry. Envelopes containing entries for more than 10 dogs shall be returned. If you include a **legible** email address, we will notify you of the acceptance status of your entry. Dogs may not switch between Regular and Preferred classes within the weekend.

Electronic Entries – You may enter these trials online and pay by credit card. Entries will be confirmed within 24 hours of receipt. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Mixed breed dogs enrolled in the AKC Canine Partners program may be eligible to enter all-breed AKC agility trials at the club's option. Mixed breed dogs entered in these events must list the breed name as "Canine Partner" (mixed breed) and not as a breed hybrid and must include their AKC Canine Partners number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 816-3776. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
